Plaintiff Todd Wodja and Defendant Washington State Employees Credit Union (collectively the "Parties") respectfully and jointly request entry of the below order revising Section 12 of the Class Notice to reflect a higher figure for the cap on the Claims Administrator's fee.

**STIPULATION**

The Court's February 2, 2018 Order granting preliminary approval of the Parties' class-action settlement ("Preliminary Approval Order") approved the form of the Class Notice. Section 12 of the Class Notice indicates that the "The Claims Administrator has agreed to cap its expenses at \$56,400."

In the course of finalizing the claims information and information regarding the number of class members, the parties determined that the Claims Administrator will need to send notices to more class members than contemplated in the original cost estimate. As a result, the Claims Administrator has requested that the cap on its fees be increased proportionally to \$71,850. Class Counsel and counsel for Defendant have reviewed this request and agree that it is reasonable and that the revised amount should be reflected in the Class Notice that will be distributed pursuant to the Preliminary Approval Order.

ORDER

Based on the foregoing Stipulation and the Court having found good cause to grant the relief requested, it is ORDERED, ADJUDGED, AND DECREED THAT

The increased cap on the Claims Administrator's fee to \$71,850 is approved, and that amount shall be reflected in the Class Notice.
